## Welcome New Client!

I am delighted that you have chosen energy healing and body/mind counseling for your therapeutic needs. I use energy healing and body/mind counseling to help improve you physically, mentally, emotionally, and/or spiritually by supporting the body's natural healing mechanisms. This leads to a greater sense of well being, peace and calmness.

Regardless of where you fall in the spectrum of health and well-being, we will work together toward your healing goals. I would also be happy to work in conjunction with any other professionals.

Since this is the first time we will be working together, I have included some information regarding office policies and procedures to help you get the most out of your session(s).

## Scope of My Practice and Training

My training includes over four years at the Lionheart Institute of the Energy System of Healing in Los Angeles, California where I received a certificate as a Energy Healing Practitioner and a Body Mind Counselor. The Energy Healing Practitioner program is recognized by the state of California. I have been practicing professionally since 2009.

As an Energy Healer Practitioner and Body Mind Counselor, I am not trained to diagnose conditions, prescribe substances or perform medical treatment, nor interfere with the treatment of a licensed medical professional.

## Your First Session

For your first session, please plan to be here for 1 1/2 hours. After the first appointment, sessions will be one hour in length.

Your first appointment will include a confidential client information sheet in which I will ask you to tell me about your health history.

## Client Participation

This is your time, so please let me know if there is anything I can do within the scope of my practice to make your session more comfortable or effective. For example, I can adjust the temperature of the room or volume of the music, or the amount of pressure I use.

## Confidentiality

All sessions will be kept confidential as the law allows. I may at times speak with professional colleagues about our work without asking permission, but I will disguise your identity.

## Tardiness and Cancellations

Please plan to arrive on time for your appointment. If you are late, the session will end at its scheduled time. If you do not show up for an appointment, you will be billed for the entire session.

Please provide at least 24 hours notice of cancellation. If you must cancel with less than 24 hours notice, you will be charged in full for the session.

## Hygiene

I ask you to be free of perfumes, odors and cigarette smoke. Please remove your shoes after entering the treatment room.

## Intoxication

Please do not arrive for your session under the influence of alcohol or substances other than prescribed medication. If there is any reason for me to suspect that you are intoxicated, I will exercise the right to terminate the session immediately. You will be charged in full for the session.

## Client/Therapist Relationship and Misconduct

My relationships with my clients are strictly professional and therapeutic in nature. Any client who attempts to sexualize their session, or uses disrespectful language or behavior will be dismissed immediately and billed in full for the session.

## Out Calls

Out calls such as visits to the client's home, hospital, or any other care facility will be charged at the regular rate plus travel time and 55 cents per mile.

## Telephone Policy

Healing sessions can be done over the phone. The same fee will be applied as a healing session in the treatment room.

If you call me and I am unable to take your call, please leave a message along with best times and phone numbers to reach you. I will do my best to return your call the same business day. If I am out-of-town, I will call you the next business day after my return.
